A description of the efforts made to determine the mine or location of the origin of the Conflict Minerals.

In order to determine the origin of any parts/components/assemblies that contain Conflict Minerals you should communicate the new SEC requirements to your suppliers of any components/parts/assemblies

If your products contain any of the conflict minerals then you need to supply smelter information and more information is required. This information will be requested yearly going forward.
